

**DESTINATION** Backpacking Trip - Dungeness River - Olympic National Forest.

**DEPART** Meet at Wedgwood Presbyterian Church parking lot at **8:00am Saturday**, March 10.. The troop will depart at 8:30am sharp. Rosters, maps, driving instructions in the parking lot. Drivers parking overnight will need to have a Forest Service Trail Park Permit (\$5/day or \$30/year).

**PROGRAM** Because this hike will be into a Wilderness area, we are required by Scouting and Forest Service policy to split into groups of no more than 12 people (including 2 adults) per group AND maintain ½ mile distance between groups, including campsites. 3.5 mile hike along the Dungeness River to Camp Handy. This trail is a gentle grade through stands of old growth Douglas fir and large rodedendron. It is located in the rain shadow of the Olympic Mountains.

**ROUTE** **Driving:** Take Edmonds Ferry to Kingston. West on WA Highway 104 (about 21 miles). Take slight right onto U.S. Route 101(west). Go about 18 miles towards Sequim. Just past Sequim Bay State Park, turn left onto Palo Alto Road. Drive to the end of the pavement, approx 6 miles. The road becomes Forest Road 28. Drive 3 miles to Forest Road 2860, then turn right and drive 11.7 miles to the Upper Dungeness trailhead (trail #833).

**EQUIPMENT** This trip is an overnight backpack hike. Troop 166 practices Leave No Trace - i.e. leave only footprints, take only pictures - so bring garbage bags, and plan carefully. Bring your 10+ essentials including extra clothing and rain gear for possible conditions, sun protection, map and compass, water bottle, trail food, waterproof matches and fire starters, a pocketknife, first-aid kit, flashlight and batteries, overnight camping gear including a warm sleeping bag. Scouts must be prepared for potential wet weather and cold. Patrols are required to bring sufficient tents, tarps and dining flies, **water-purification supplies- Giardia is present-**, sufficient large water containers, and coordinate cooking gear, stoves and fuel. Campfires are NOT permitted in this area.

**FOOD** The patrols are responsible for preparing dinner on Saturday and breakfast on Sunday. Each patrol will invite an adult to join them. Provide your own trail food, and sack lunches for Saturday and Sunday unless your patrol makes other arrangements.

**FEE** **\$25.00 CASH** covers transportation and permits. Provide an additional **\$8.00 CASH** to your patrol ( **all** adults, too) for food expenses at the church parking lot on March 10.

**RETURN** Troop will arrive back at cars at the trailhead between 1-2pm. Troop will call the phone tree contact on the way back.

**SIGN-UP** **Signed permission slips** and **\$25.00 CASH** are due **Monday March 5 at the troop meeting** to Brian Lenker.
